### IN APPRECIATION EULA M. BECKWITH

**WHEREAS**, Mrs. Eula M. Beckwith served as a member of the Board of Trustees of the Teachers' Retirement System of Louisiana (TRSL) from January 1, 1997, through December 31, 2011, representing members of the System working in the Second Membership District; and

**WHEREAS**, Mrs. Beckwith served on the Elections, Personnel, Investment, Executive, Budget & Finance, Membership & Entitlements committees of the Board of Trustees of the Teachers' Retirement System of Louisiana; and

**WHEREAS**, Mrs. Beckwith was a strong advocate for legislation that improved the quality of life for many retirees, including three percent cost-of-living adjustments in 2007 and 2008, and a supplemental retirement benefit provided in 2009 for retired teachers living at or below the poverty level; and

**WHEREAS**, Mrs. Beckwith worked tirelessly as an educator and professional school counselor to promote the educational, social, and mental development of students in the Orleans Parish School System and the Recovery School District for more than 40 years; and

WHEREAS, Mrs. Beckwith earned National Board Certification for Counselors and maintained membership in numerous professional organizations such as the Louisiana School Counseling Association, the American Counseling Association, the United Teachers of New Orleans, and the American Federation of Teachers in order to further her knowledge and expertise in areas that would impact her ability to counsel students; and

WHEREAS, Mrs. Beckwith has been a member of the Louisiana Association of Public Employees' Retirement Systems, the National Council on Teacher Retirement, and the National Conference on Public Employee Retirement Systems to gain insight and understanding of the issues and challenges facing public pension systems in the state and nation; and

**WHEREAS**, Mrs. Beckwith has remained committed to civic awareness and responsibility, life-long learning, quality education, and a secure retirement system; now, therefore, be it

WHEREAS, Mr. Jung joined the Teacher Retirement System of Texas in June 1996 as its chief financial officer; his accomplishments included the successful implementation of a new multicurrency investment accounting system and progress toward the new automated benefits system and helping guide the development of an active member health care program; he played an important role in strengthening the communication between the retirement system and the Texas Legislature, continuing to work closely with legislative committees; and

**WHEREAS**, Mr. Jung was named deputy director of the Teacher Retirement System of Texas in October 2001, became interim executive director in September 2003, and began his service as executive director in May 2004; and

**WHEREAS**, on August 31, 2011, Mr. Jung stepped down as executive director of TRS and was named Executive Liaison to the Board of Trustees until his retirement on January 31, 2012; throughout his years of leadership, he maintained the highest standards of professionalism and consistently demonstrated excellent management skills, which included resolving complex financial and governmental issues; and

**WHEREAS**, Mr. Jung served as executive director at a time when pension fund net assets grew from \$71.7 billion to more than \$107 billion; the number of members in the system grew from approximately 1 million to more than 1.3 million; and

**WHEREAS**, his integrity, professionalism, good judgment, and caring for others earned him the respect and admiration of those who have worked with him; and

WHEREAS, in addition to his innumerable accomplishments in various roles at the Teacher Retirement System of Texas, he served as a member of the task force for higher education financial reporting for the Governmental Accounting Standards Board; he was recognized as the 2002 Administrator of the Year by the Texas State Agency Business Administrators' Association; he served as President of the National Council on Teacher Retirement, and as a board member of the National Institute for Retirement Security; now, therefore, be it
